GOSWIM DIRECT DEBIT TERMS AND CONDITIONS



GENERAL

A Parent/Guardian must remain in the leisure centre at **ALL** times for the duration of the lesson. An appropriate working relationship will be built with the participant/s based on mutual trust and respect.

By signing the form overleaf, consent is given to administer any urgent medical treatment to your child which is considered necessary by the medical authorities. Please make sure your child brings their medication (including asthma pump and epi pen) to their activity and inform a member of staff if required.

Lessons run for 50 weeks a year, with a 2 week break over Christmas, the direct debit is a pro rata of the 50 weeks. No refund will be given for cancellations. We will endeavour to ensure class cancellations do not happen, however sometimes this is beyond our control. All Activities/Lessons are non-refundable.

Members will only be able to attend swimming lessons provided their membership is current and fully paid up.

DISCOUNTS

Customers with a valid direct debit membership will be able to access additional benefits which include 10% off swim sale stock, free public swimming and a £1 reduction to Go Play entry for the child enrolled on the course. Medals and all other certificates will be included in the monthly direct debit price. Any loss of certificate or medal will be replaced at full price.

Sibling discount is available for families with more than one child enrolled in the Nofio Swim Academy. For existing customers, please see a member of the customer service team to discuss how to apply the discount. For the discount to apply you must ensure that all children's accounts are linked through the online home portal. We reserve the right to revoke this discount if the conditions above are not met.

CANCELLATION

To cancel your membership, please attend Pontypool Active Living Centre or Cwmbran Stadium to complete the cancellation process with a member of our team. If you are unable to attend the centre, alternative cancellation processes can be discussed with our team by emailing goswim@torfaenleisuretrust.co.uk. Cancellations received after the 15th will be subject to the collection of the following months payment.

Cancellation of the direct debit without prior notice to Torfaen Leisure Trust, will result in the loss of your child's

swimming lesson space. Action will be taken to recover the full balance owing for any outstanding amounts, where the cancellation policy has not been followed.
