- To complete general cleaning duties to the agreed quality standards as per the centre schedules. At all times fully complying with COSHH regulations.
- Ensure all areas of the building and surrounding areas are clean and tidy.
- Complete all required checks and inspections in line with the agreed standards. Report and record completion of these tasks using the centre processes in place at all times.
- Carry out First Aid where necessary.
- To be customer led and focussed at all times and engage positively and in a professional manner with all centre customers and visitors.
- To undertake any other duties deemed reasonable by a Line Manager to ensure the very highest level of consistent service delivery to all our customers.
